HOW TO MAKE AN APPOINTMENT ?

SAVE ALL FORMS (PDF)

Save the forms (PDF) and name them this way : Who filled out the form_Patient's Name_Birth Date EX: Father_Charles-Patenaude_28-10-2034

HAVE THE FORMS FILLED OUT BY THE CONCERNED PERSONS

Make sure that all the documents are properly named before sending them back to us. It's important that ALL sections are completed (in the the best possible measure). If you cannot have the concerned person fill out the document, then you may have another person close to you to complete the form. If none of these alternatives are possible, then you may, as a last resort, skip that section. Please let us know in you return e-mail. Do not print these documents; for they are already in editable PDF, please fill it out on your computer/electronic device.

ASSESSMENT DETAILS

FIRST VISIT - EVALUATION ASSESSMENT

The first consultation will be scheduled with a nurse practitionner. An ECG and bloodwork will be required; a referral to have them done in either the public care system or our private clinics (ExcelleMD) will be given to you (ECG = 65\$ and Bloodworks = 170\$)

SECOND VISIT - TREATMENT PLAN

A second consultation will be scheduled with a doctor that has an ADHD expertise. ECG and bloodworks results must be received prior to scheduling the appointment. Please have your weight and blood pressure reading (Mandatory). If you don't have a tensiometre, please ask your pharmacist.
